Last Thursday night we had four inches of rain,

the most I have ever seen here. Even now, three days later, there are still unusually large puddles of water. It just proves the importance of the Town's effort to limit impervious surfaces and have as much ground draining as possible. Several new Town Ordinances were approved at the Town Council meeting last Friday December 12th. These include new Ordinances on: Property Maintenance; the use of air compressors for building; the consolidation of various fees from multiple Ordinances into one; and renovation/remodeling/alteration and adding permit requirements for interior

renovation/remodeling/alteration, central propane service connection and geothermal well installation. All these new Ordinances can be seen at the Town's web site at (<u>www.southbethany.org</u>) under Bulletin Board. A proposed street vendor Ordinance had its second reading and will be proposed for adoption at the next Town Council meeting on February 13, 2009 at 7pm.

The Town is now putting out a bid for a vendor to sell snow cones, drinks, etc from a small vehicle on the beach next summer. They are also starting work on building up and improving the beach access walkways so that they will not be so steep and will be easier to navigate. Today, the State of Delaware began to correct many deep ruts that have developed on many of the walkways.

Finally, some of you will want to know that the scheduled bulk trash pickup day next year will be May 30^{th} (Memorial Day is the weekend before), so the SBPOA yard sale will be the prior weekend on May $23^{\text{rd}} \& 24^{\text{th}}$.

Page 2 of 4 WINTER 2008 Curbside Recycling Program Is Flourishing by Councilman Jay Headman

The Town of South Bethany has been very successful in implementing its new recycling program. In September 2007 South Bethany was one of the first towns in Sussex County to adopt a voluntary recycling program with the Delaware Solid Waste Authority (DSWA). Before the program began, only 25 families participated. Today, over 700 property owners have signed up for the program with over 6000 pounds of recycling materials being collected a week and over 33 tons over six months.

Even though each property owner is billed for the service, participation in recycling is voluntary. The service began the first week in January with Fridays as the pick-up day. DSWA provides biweekly service for the months of October through April and weekly from May through September.

The curbside program is "single stream" recycling. Participants choose either a 35 or 65 gallon cart provided by DSWA and are required to wheel them to curbside for the scheduled pick-ups. Property owners can have their carts at curbside if they are kept in a bin that has an opening on the street side.

Even though the program has been extremely successful, the Town is facing some challenges in ensuring all carts are returned to their proper locations after pick up. In order to address this issue, the Town has sent letters to property owners of rental properties, placed flyers on carts left out, and placed more information on the Town's website.

The Delaware Solid Waste Authority's manager of the state wide recycling program, Rich Von Stetten, is very pleased with South Bethany's recycling program. He stated, "DSWA is very pleased about the success of the implementation of South Bethany's recycling program. The partnership between the Town and DSWA is a model on how a community and a government agency can work together to implement a program."

In order for DSWA to roll the recycling cart out of the bin and roll it back into the bin, DSWA requires that the opening of the bin be on the street side. Below are examples of suitable bin modifications.



Sign up for recycling on the Town's <u>http://southbethany.org/recycle_form.html</u> or at Town Hall. Recyclables are collected every Friday from May thru September and the first and third Friday from October thru April.


