NOTICE OF REGULAR ASSOCIATION MEETING

This is your written notice for the next regularly scheduled meeting. The meeting will be on Saturday, <u>May 1</u>, (not April 10th or 17th, as previously scheduled) 2010 at 10:00AM at the South Bethany Town Hall. At this meeting you will have an opportunity to have coffee and donuts and meet with the South Bethany Town Council and Mayoral Candidates. The positions open are for three Town Council Seats and Mayor with the application deadline being April 15th. Once we know who is running we will invite them to meet you on <u>May</u> <u>1st</u>. At this meeting we will also approve the SBPOA annual operating budget for next year. The proposed budget can be found in the Treasurer's Report Section of this newsletter.

PROPOSED BY-LAW CHANGES Changes are highlighted in *bold italics*

ARTICLE I NAME AND TERRITORY

- Sec. 1. The name of this organization shall be the South Bethany Property Owners Association, Inc., hereinafter referred to as the Association.
- Sec. 2. The membership of the Association shall be open to: *owners of property within the corporate limits of the Town of South Bethany, Delaware, including individuals, corporations, partnerships, and business firms.*
 - a. Owners, *and spouses/partners of owners*, of property within the corporate limits of the Town of South Bethany, Delaware.
 - b. *including individuals, Representatives of* corporations, partnerships, and *business firms businesses who own property within the corporate limits of the Town of South Bethany, Delaware.*
 - *c.* Members, as identified in a. and b. above, may designate on the SBPOA application two (2) individuals to replace them as members of SBPOA.

ARTICLE III MEMBERSHIP AND DUES

- Sec. 1. Each owner of property in the Town shall be eligible for membership in the Association. The property owner(s) is/are the name(s) appearing on the deed(s). Corporation(s), partnership(s), and business firm(s) managers shall designate, in writing, the officer or individual who will represent the corporation, partnership or business firm.
- Sec. 2. 1. Each owner of property Property owners who meet the requirements of Article I Sec. 2 a and b, desiring to become an Association member, shall file an application for membership and shall indicate up to two (2) individuals for membership on the application form.
- Sec. 3. 2. The annual membership dues will be payable on a fiscal year basis for the period beginning on June 1 and ending on May 31 and shall be established at the

March/April January/February regular meeting for the following fiscal year.

Sec. 4. 3. Each owner of property individual whose application has been received and whose current Association dues have been paid shall be a member in good standing.

ARTICLE V VOTING

Sec. 1. Voting status is determined by annual submission of an application for membership in the Association and payment of an application fee. *Thus, property owners of houses, lots, or businesses in South Bethany who have filed such application and paid such fee are entitled to one vote irrespective of the number of owners listed on the deed, or the number of properties owned. ARTICLE VII POWERS AND DUTIES OF OFFICERS

Sec. 5. The Treasurer shall prepare an annual operating budget for approval by the Executive Committee, and subsequently by majority vote of the Association members at the *March/April January/February* regular meeting.

ARTICLE VIII COMMITTEES

Sec. 3. An Information Committee, composed of SBPOA volunteers to communicate information to SBPOA members concerning the Town of South Bethany through the SBPOA Newsletter "Shore Lines" and through the use of e-mailings *and website.*

ARTICLE IX FISCAL YEAR. MEETINGS AMD QUORUM

REPORT FROM JAY HEADMAN, Chairman Of SB Water Quality Committee

The South Bethany Canal Water Quality Committee goal is to help make our canals swimmable and fishable. We continue to look for ways to accomplish this goal by educating our community on water quality issues, working with the town, state, and federal governments to eliminate pollutants entering our canals, reviewing the Town Ordinances and if necessary, creating new ones that would eliminate pollutants entering our canals, and working closely with the Center for the Inland Bays. Currently I am co sponsoring a new town ordinance, Ordinance 153-10, with Councilman John Fields. The purpose of the ordinance is to restrict the amount of impervious surfaces permitted in the setbacks. In addition to this, members of the Committee have been working with DelDot, CIB, Center for Watershed Protection, Middlesex Beach, and Sea Colony to finalize the study of the Anchorage Canal Assessment Study. The final report should be completed this spring, and a public meeting will be scheduled to share the findings and recommendations. George Junkin, a committee member, has submitted a proposal for a Clean Water Advisory grant. The grant would be used to install a diffuser system in one of our canals in order to improve the water quality. We just heard that our proposal was not one that was selected.

This year we plan to continue to monitor the canal's water quality. Dave Wilson and his team systematically monitor 7 sites in our canals for dissolved oxygen, water temperature, salinity, nitrogen and phosphorus, and bacteria. In addition, the CIB and DelDot installed a continuous dissolved oxygen monitor in one of our canals. Allan Allenspach leads the Oyster Gardening Program. This program has approximately 110 floats in our canals. Due to the generosity of the SBPOA, he was able to purchase new spat for the floats last year.

Our committee believes strongly that in order for our town to be successful in improving the water quality in our canals, we need every one in our community to do their part. Our committee will continue to place articles in this newsletter, the SBPOA website, and the *Zypher* that will provide ways you can help. Additionally there is a publication, *Delaware Coast—A—Sys, An Environmental Risk Assessment Guide For Protecting Coastal Water Quality,* from DNREC that details what homeowners can do to improve water quality. 

Tony Pratt, from the Shoreline and Waterway Management Section of DNREC, reported at the South Bethany Town Council Meeting, 2/12/2010, that the DNREC would move as much sand back to the dune as possible by March 20, 2010. This is to meet the schedule for planting dune grass by volunteers on March 20. Before Memorial Day the DNREC will repair all the dune crossings and rebuild the fences that were destroyed by the November 2009 Nor'easter , "Nor'Ida".


THREE HUGE SNOW STORMS HIT IN LESS THAN 3 WEEKS
