- \* Next June will be here before we know it! And with June and the Bull Roast, we have SBPOA Officer elections. We will have 3 Offices open this year and will also need someone to lead the Nominating Committee (see the article below).

#### OFFICER OPENINGS /NOMINATING COMMITTEE LEAD

This year three Officer positions are due for re-election in June. They are:

President (Linda Lewis will not be running),

2nd VP (Dan has served 2 terms),

Treasurer (Linda Paul is considering running again).

We will definitely need a Nominating Committee Lead to solicit and identify candidates. If you are interested in running for one of these positions or interested in leading the Nominating Committee, please call Linda Lewis at 302-475-1506.

#### DIRECTORY LEAD/COORDINATOR

At our Oct 6 meeting, the membership agreed to fund and support a 2013-2015 SBPOA Directory. We need a Lead/Coordinator for this effort. This position is responsible and accountable for the following:

- Obtaining any volunteer support needed to produce the Directory
- Ensuring that printing costs and any other related costs to produce the Directory do not exceed \$5,000. The only costs that will be approved for payment are: pre-approved printing costs (approved by Executive Committee), appropriate mileage at federal approved rate with approved documentation including date of travel, to and from location mileage costs are included in the \$5,000 budget
- Obtaining at least \$13,000 in ad revenue
- Ensuring that all phone numbers published have the property owners' permission to publish
- Managing the data entry for all SB property owners names, SB address and approved phone numbers or blank if no approval received
- Working with the membership committee to design appropriate permission form for all residents.
- The Directory listings will be by last name as well as by street. All property owners will be listed with SB addresses only. Phone numbers for members

and non-members will only be printed with owner's permission. The traditional time line for publication is May 30th but other dates can be considered.

The Directory is a membership benefit and will be distributed to Members Only. We will need a volunteer no later than January 1 so that the Directory information can be sought during the Membership drive. If interested in leading this effort, please call Linda Lewis at 302-475-1506.

#### IMPORTANT CHANGES TO THE BULL ROAST

Our 2012 Bull Roast will be held on June 1, 2013 at the Town Hall. At the October 6th general meeting, the membership present passed the following proposal:

Since the SBPOA Annual Bull Roast is a community event for those households that belong to the SBPOA and the SBPOA provides 2 FREE tickets per member household, these tickets are intended to be used by the SBPOA members. If the second member is unable to attend (or there is no second member), the second ticket can be used for one member's guest as long as the member is attending.

Last year we had over 250 people attend. We need to have an accurate count of attendees to continue to provide enough food; therefore, we will **REQUIRE RESERVERATIONS BY MAY 1, 2013. PLEASE NOTE THE FOLLOWING CHANGES:** 

- \* Reservations must be made to attend the Bull Roast.
- \* Reservation requests will accompany the membership form mailed in early April.
- \* Reservations will be accepted up to May 1, 2013.
- \* Reservations can only be made If 2012/2013 \$20 membership dues are paid.
- \* Reservations will be accepted in the order they are received.
- \* Our current budget is intended to handle up to 270 members. If we receive more than 270 reservations, an emergency general meeting will be convened to approve the required additional funds. If approval is not provided, those reservations above 270 will be turned down.

\* Memberships will not be accepted or processed at the Bull Roast.

## 2<sup>nd</sup> Annual Adopt Beauty Contest"



# PROTECTING YOUR HOME AND OTHER CRIME PREVENTION TIPS

- · Locks if old replace, use deadbolts.
- · Doors make sure sturdy, if old replace.
- Secure sliders use broom stick in track or buy special lock.
- · Windows make sure they are locked, if old/broken insert a peg or nail.
- · Shrubs keep trimmed, away from windows and entry ways.
- · Lighting timed or motion detection lighting on outside.
- · Do not let strangers into your home.
- · Consider installing a burglar alarm system.
- · Secure outside valuables bicycles, canoes, small boats.
- Lock your cars secure valuables. Do not leave computers, cameras, guns, GPS, money, purses in car.
- · Home should look occupied (timed lighting, use call forwarding when away).
- Do not give the criminal the tools he needs to break into your home (ladders, hammers, pry bars).
- · Avoid sitting electronics or other valuables in places visible from outside use drapes if possible.
- Do not give out personal information over the telephone (SS#, credit card #, bank account #, living alone, time of day when home will be unoccupied. If you did not initiate the call, end it quickly without giving out personal information).

- Door to door solicitation Call the Town Office to ascertain if they are licensed. Do not pay for work up front, get a contract, or even avoid entirely (engage own contractor).
- Engraver mark your valuables (should property be stolen, will help identify). An engraver can be borrowed from the South Bethany Police Department. Contact the South Bethany Police Department at 539-3996 for information about the Property Identification Program.
- Call the police when you see suspicious activity. If you notice anything suspicious in your neighborhood, call 911 immediately.
