

# <u>LETTER FROM THE PRESIDENT</u> – Kathy Jankowski

This is the membership edition of our newsletter. Please take the time to fill out the membership form and return it with your membership fee (\$20) by March 31<sup>st</sup>. The updated information you return will appear in our new directory due out May 31, 2011. I thought this would be a good time to review what our association does for its members.

Not many people know that the South Bethany Property Owners Association existed before the Town of South Bethany. While the Association provided many of the needs of our property owners, the Town was incorporated so that South Bethany could qualify for governmental funding. Therefore, many of the needs that were provided by the Association are now provided by the Town. However, the objectives and actions taken by your Association continue to be based on your needs and wants and, hopefully, complement what is provided by the Town.

Neighborhood Watch Program—This program was established to watch over your home when you are not here. Over 60 Watch "walkers" monitor your house for frozen pipes, wind damage, "critter" invasion, and unusual activity. They work closely with the Town of South Bethany police force to protect our neighborhood. A placard for your window or door is provided to deter unwanted visitors. This volunteer effort is much appreciated by everyone in our community.

**Telephone and Buyers Guide Directory--**This booklet provides contact information for South Bethany property owners, both by name and by address. It also provides a list of services and restaurants--information helpful to residents and our visitors. More than 100 advertisers help fund the printing of this booklet, so we hope you will show your appreciation by using their services or frequenting their establishments.

*Shore Lines* Newsletter--Four (4) times a year, we publish a newsletter with information we believe you will find helpful, separate from information provided by the Town in the Zephyr newsletter.

**Email Updates--**Often times, we will send emails with more time sensitive information and requests that cannot wait for the publication of the newsletter. If you wish to receive these notices, it is important that you let your email provider know that this is NOT spam or junk mail.

**Annual Bull Roast--**On the first Saturday of June, the SBPOA sponsors a catered buffet dinner for all SBPOA members. This is a great opportunity for you to get to know your neighbors.

As of January 1, 2011 the State of Delaware mandated that landfills will no longer accept yard waste co mingled with trash. Please do not place yard waste in your existing trash cans. The town-wide curbside service for yard waste starts March 8<sup>th</sup> and will continue once a month on the 2<sup>nd</sup> Tuesday of each month.
