

LETTER FROM THE PRESIDENT

Summer is not too far away, after a long and dreary winter, so I am sure that every homeowner just cannot wait to utilize their beach homes and enjoy the beach, boating and general relaxation South Bethany has to offer.

This winter has been arduous and somewhat extreme with many freezing days and large amounts of snow fall. The South Bethany Property Owners Association has in place a volunteer Neighborhood Watch program for its members.

The Neighborhood Watch Program entails that all members to have a choice, at no additional cost, of not just having your house to be checked from the street level for any open windows, lights left on, burst and/or leaking water pipes throughout the winter months or any other type of damage/disturbance during your absence from the beach.

This program now offers an entitlement to a "walk around service", in which one of the 60 or so "volunteer walkers" walks around the property to check and offer a higher level of service. This is a great "Peace of Mind" service for our members.

This year we had in the vicinity of 15 houses that experienced problems that where identified by the walker program and the owners were subsequently contacted. Unfortunately in some cases the information provided to the SBPOA was not up to date and led to difficulties and delays.

Attached is your very own, private information we have on file. Please **CAREFULLY READ** and **ADJUST** the contact details we have on file. This year you will notice that we request an **EMERGENCY NUMBER 1 Contact phone number**, this is a number that you will answer with regularity in case that you, the homeowner needs to be contacted in any emergency situation. (as always this information remains private and is under no circumstances ever released without your prior written consent)

We also send you vital and critical information via email throughout the year regarding topics that impact you, as a homeowner.... again ensure that we have an accurate email for each member.

How about a party? MUST RSVP BY MAY 25th 2014

As part of your membership, SBPOA organizers it's **ANNUAL BULL ROAST**, this catered buffet dinner function is available only for its 2014-2015 paid members and will be held on JUNE 7th 2014 at the Town Hall and is the kick off to the new membership year.

It will be catered by Jimmy's Grille and serving fabulous BBQ Food, along with Alcohol and Soft Drinks. The food service will start at 5.30pm and end at 7.30pm.

Since the SBPOA Annual Bull Roast is a community event for SBPOA member households only and this year the SBPOA provides 2 subsidized tickets per member household (\$15.00 per person) these tickets are intended to be used by the SBPOA members. If the second member is unable to attend (or there is no second member), the second ticket can be used for one member's guest as long as the member is attending.

There is a finite limit of **240 guest only** and it works on a first in with RSVP and a \$10 payment per member attending. South Bethany Property Owners Association will be subsidizing the meal cost with \$15 per member.

There is no limit on extra paid tickets – cost for additional adult tickets are \$25 and children 12 and under are \$12.

You must RSVP with your check payment (\$10 per member attending) by MAY 25th 2014.
